

Status Update

And here we are. The assessment duration of Me implied by the apostate system (implied on an inherently non-credible counter-Divine Will, counter-True Nature basis that is) has apparently lapsed. Their “scan” finally complete, the result a success. The organizing symbolism has been mixed: a greatly-implied ‘null mode’ of symbolism on the part of the apostate system, implying that what they’re non-overtly going on about has no reliable basis to anything in actual fact (which would have been the case regardless given the counter-Divine Will, counter-True Nature basis on which the organization remains), one heck of a lot of [ob[█]lisk] symbolism implying [Os[█]ris] with some [kits[█]ne] symbolism referencing Myself, and various implied mutterings about a few non-overt schemes and narratives they’re supposedly trying. Examples: Standard Babylonian Kabbalist organizing symbols carefully selected and arranged to present the idea of a supposed non-overt ‘*Christian-based resistance effort*’, complete with the use of the usual counter-Divine Will position identifier symbols (this time purportedly to indicate the supposed ‘opposition’), and implications that now what they’re doing is Working to secure the situation and make sure the rank and file apostate system personnel transition their loyalties in accordance with the purported inauguration. ‘Hit[█]chens’ raz[█]r’ naturally applies. So now not only is the overt behavior of the apostate system invalid (with regard to truth, legitimacy, Divine Will alignment and so on), its non-overt behavior in addition to being invalid due to the organization’s counter-Divine Will, counter-True Nature basis is also implicitly disav[█]wed by the organization itself. Divine Will principles are the ultimate constants, however much the telepaths and propheciers have non-credibly implied to Me that it’s all a matter of subjective Willworking and ‘ya just gotta believe’ in order for them, or indeed their own loyalty to Divine Will-derived authority, to take effect. For them to adopt the position that they’re matters of subjective Willworking rather than fundamental Laws *is* to adopt a counter-Divine Will, counter-True Nature basis.

Why apostate system rank and file would have a problem with My taking office isn’t quite clear, particularly as My basis is Divine Will- and True Nature-aligned and My agendas too; the results would be a definite ‘win’ for everybody, so a motive for dissent appears lacking. Add to that the capability of the telepaths and propheciers to notice untoward behaviors well in advance and pre-empt them and the implied, but disav[█]wed, messaging starts to look disappointingly non-credible. Nor is it especially clear why, given the capabilities of the telepaths and propheciers, such an effort if it were indeed necessary would be started here in realtime and only now. Rather, it appears based on the available data I currently have to be yet another rationalization for more time spent on a counter-Divine Will, counter-True Nature basis. Alternatively, the idea that the ‘upper ranks’ of the apostate system lack deftness, competence and efficiency isn’t borne out by My experience with their handiwork.

I’d just ask the apostate system of course, but while it remains on a counter-Divine Will, counter-True Nature basis the reliability of their responses would be hardly guaranteed.

I’ll admit, I watched the clock tick into New Years’ D[█]y half-exp[█]cting some direct, overt

approachment by them because we've got a lot of Divine Will-aligned Work to do and quite a lot to sort out. I was interested to see how and if they'd sort it out. Nada. I say half-expecting not because what they imply from their current counter-Divine Will basis is inherently credible, but rather because doing so would have been in everyone's best interests and been among the most peaceful, amicable and force-saving options available to them.

When the apostate system had non-overtly implied that it wanted an evaluation period to determine whether I was on a Divine Will- and True Nature-aligned basis or not, it offended. Primarily because it by definition set aside My concerns about the apostate system continuing to systematically violate Divinely-conferred rights in the interim and appeared to be an effort to shift the topic to something irrelevant. Secondly, because an organization self-evidently operating on a counter-Divine Will, counter-True Nature basis not only seemed unlikely to come to a fair and just determination but also seemed unequipped with the working familiarity with the application of Divine Will principles to come to such a determination even if they were so inclined. And partly because it was a matter of 'situation normal' from them: disrespect predicated on a counter-Divine Will, counter-True Nature basis they were still Choosing, accompanied by a seemingly endless sequence of non-overtly implied narratives without a thing being done to correct the widespread overt injustices the organization was continuing to implement.

Then I reasoned that I could apply the experience as a sort of *'teachable moment'* for the purposes of providing Divine Will alignment to the People. If the apostate system botched it, it would then be a well-publicized if non-overt event providing an example to the rank and file personnel of the inherently non-credible nature of a counter-Divine Will, counter-True Nature basis and why they shouldn't trust it and couldn't remain in an organization predicated on such a basis. And if the apostate system recognized My Divine Will- and True Nature alignment and superior authority resulting from it, I'd have 'inherited' the system and could then sort it from the ideal position: from within, and 'at the top' as the officially recognized authority figure.

Incidentally some have implied, credibly or not, concern for why I didn't put out My usual December 7th release. As it happened the apostate system non-overtly suggested to Me that it would be assistive to getting everyone back into alignment with Divine Will if I were to do a release not providing new information as such, but rather emphasizing specifically to the rank and file personnel something I'd been saying throughout: namely, the inherent unreliability of anything implied by those Choosing a counter-Divine Will basis. For example the incumbent recognized authority figure within the apostate system, and the apostate system proper while it continues to languish on such a basis. Since despite their counter-Divine Will basis they're familiar with Divine Will principles and the vital need for them and alignment with True Nature, this seemed like something I had it within My wherewithal to do to assist everyone. A bit of work perhaps, but given that it was in everyone's interests and evidently something the apostate system on its current counter-Divine Will basis was unable or unwilling to express directly, sure I could assist in that regard. I eagerly set about writing up the release and while in-process noticed that it could perhaps be misconstrued as having 'accepted something of value from those on a counter-Divine Will basis'. Would it be so interpreted, though? I had no

means to be sure, given again the inherently non-credible position of those Choosing a counter-Divine Will basis. Again the “scan” or evaluation period the apostate system had been non-credibly implying had no guarantee of validity, but I’ve found that to achieve consensus recognition of Divine Will alignment an authority figure must not only be fair, they must also be *seen* to be fair. As the professed “scan” duration was nearly up, I assessed that making that specific point to the rank and file personnel had long been part of the reason I’d been patiently allowing it to finalize. Best to allow it to complete, illustrate patience, forbearance and a best effort on My part to resolve the situation peacefully and amicably, and if or when the apostate system publicly demonstrated its lack of followthrough the point would be clearly evident to the rank and file personnel as planned. And to keep any other release on that date from being misconstrued I was careful to do the very opposite: put out no release whatsoever. Just occasionally, the clearest statement of Divine Will-aligned position one can make is to refrain from comment.

On that, the apostate system have non-overtly been deploying the usual counter-Divine Will and disrespect (and indeed abuse) symbolism and imagery, yet blending it with various supposed ‘inversion’ and ‘not manifested yet but gosh we’re trying for it’ symbols. Not just now but throughout the implied “scan” period, and for as long as I’ve encountered them, and evidently throughout the organizations umpty-thousand year career span. Technically that’s implied by the apostate system to be acceptable standard practice. Not unlike a math equation, this symbol over here ostensibly ‘inverts’ that symbol over there, this thing ‘cancels out’ that other, and the message is read as being perfectly aboveboard and legitimate. But these are occultists with a ‘Don’t speak or think it if you don’t mean to invoke it’ philosophy. Finding or creating any number of socially-acceptable pretexts to present counter-Divine Will and disrespectful symbolism instead appears to be just part of the subversion agenda, and part of a Choice for disloyalty. As such, they’ve been dispensing what appears to be knowing, Willful and avoidable routine and systematic disloyalty, abuse and indeed blasphemy throughout as part of a most illegitimate standard practice. For comparison, most non-overtly aware personnel and I are mutually familiar with the symbolic language of a certain other group or franchise: It cursorily implies successive ‘levels’ of ‘inversion’ which purport to ‘invert’ or make legitimate all manner of disrespectful and non-benevolent symbolism and imagery, and ‘its’ personnel use the system as though it were perfectly normal and acceptable. But for those senior personnel who are more ‘in the know’, this is recognized to be in fact abhorrent; the supposed ‘inversion’ represents instead the extent to which those junior personnel are themselves ‘inverted’ into a counter-Divine Will, counter-True Nature basis. What I’m describing here with the specific apostate system behavioral trend appears to be effectively the same thing, and I thought sharing a common reference example would help to clarify that error.

The prolonged, non-credibly implied “scan” period and the superficial pretense of legitimacy and loyalty while the apostate system continued to violate rights internationally seemed like an error I’d been encountering from them at various points throughout. Their debacle with “France” directed at Me for one, but the implied-yet-clearly-not-substantive loyalty they’d been professing during My unlawful imprisonment. And I’ve publicly recounted the error there already; it’s [here](#) in the July Mega-Exposure in the “Fix in box” chapter, in the last paragraph

on page [sixty-one] continuing onto the next page. The apostate system appear to be repeating their error and indeed their fraud.

The apostate system has appeared to try to 'layer' all manner of agendas, modes of non-overt lingo, etc. with such an invalid basis as though in an attempt to rationalize or justify it, but of course it doesn't. An invalid basis is just that: invalid, and seeking to gain acceptance for it by proffering various supposed 'nices' along with it is just the deployment of the concept of the standard [dollar] or [mask] symbols as they're used by the Babylonian Kabbalists. I've been quite patient, striving for a peaceful and amicable resolution of the situation and giving some amount of grace when I could do so without enabling their behavior. Let's keep clearly in mind the distinction between that and deeming their behavior or indeed their continued basis as legitimate or credible.

They've been deploying symbols which suggest a 'null symbolism' mode, in ways which intimate the idea more of 'unofficial', like the sort of personal, intimate, friendly, romantic subtle 'nudges' which intimate an idea within a relationship where those involved are on a legitimate, Divine Will-aligned basis and trust has been established. By contrast, they and those affiliated with the apostate system are currently most distinctly **not** on such a basis, and it would be most inappropriate on My part to regard them as though they are. In My duty to Divine Will, the People, Myself and indeed everyone (even those currently affiliated with the apostate system) I have to recognize, establish and uphold clear distinctions and parameters which accurately express and which are in accordance with Divine Will principles. As "head of household" whether of the apostate system or just My own humble clique if I can be said to have one job, that is it. That's why they pay Me the big money, at least in theory. The same is true for any "head of household", including those of the apostate system throughout its organizational lifespan.

That being the case while the apostate system had been proffering Me all manner of non-overtly implied counter-Divine Will narratives and options throughout the implied "scan" duration (and in some instances, apparently seeking to gain My trust by having certain of 'their' personnel clarify the matters while simultaneously retaining a counter-Divine Will basis, something I had a duty to reject as invalid and indeed did), I was busily doing the exact opposite: carefully evaluating the dataset I had about the situation by correlating it against Divine Will principles and identifying the inconsistencies. Paid or not, that's My job because it's My Duty.

Assessing what the apostate system had been purportedly doing with their implied "scan", their 'training mode' with Me, and their emphasis in theory if not in actual practice on Divine Will principles and True Nature, I started evaluating the longer-term scenario. Ostensibly the apostate system recognizes Divine Will-aligned authority figures on the basis of their alignment with Divine Will and True Nature. Yet once they 'get into office' the results of the apostate system in actual practice routinely and systematically transgress against Divine Will both directly and by violating (and subverting public recognition of) Divinely-conferred rights. Even just the various overt agendas of the organization and its responsibility for practically every

major and minor atrocity is a testament to this. So what could cause someone Divine Will- and True Nature-aligned to 'get into office' and then lapse on that basis so thoroughly and outrageously? It's as though the system as it's been operating has been one big scheme to induce everyone onto a counter-Divine Will, counter-True Nature basis: the lower ranks through various comparatively meager strategies and inducements, and in the event that those were unsuccessful a supposed recognition of them as authority figures for the whole enterprise, but somewhere upon 'taking office' there had always been this phenomenal lapse. An organization as one rather sizeable "death trap", effectively.

I started to think about how far back this went and evaluated the symbolism and the actual physical nature of the pharaohs and the Egyptian [pyramids]. What the heck were those about? We've got [carved] [stone] [blocks] representing an overt basis. Fine, no problem there. A [triangle] symbolically representing [fire], with a [square] base representing control. Hmm. Overt control established on a counter-Divine Will basis? Yikes. And an [embedded] overt [leader], with the whole thing ostensibly being a venture '*to ensure his success and immortality in the afterlife*' per their religious doctrines, while in actual tangible fact the whole thing was oppression and slavery on a counter-Divine Will basis. This certainly added up in terms of the 'pyramid scheme' I'd been noticing from the apostate system generally. And do we not have the now-familiar media trope established by the apostate system about how [tombs] and particularly [pyramids] are themselves full of "death traps" to anyone who ventures into them?

Why the counter-Divine Will basis though? I started to research the [light] they were always talking about, particularly in the context of "the [light] overcoming the [darkness]" and so on. The [light] of truth and Divine Will, surely. That would make sense. Then I started to evaluate their emphasis on [the Sun] and found it to be a derivative of 'their' sun-worshipping cult to a very familiarly-named idol, [Baal]. The Old Testament [golden] [calf] idol, etc. Apparently they'd started in by claiming that said idol was YHWH, and then just continued the subversion from there. Evidently even very benevolent, Divine Will-aligned symbolic terms like [the Sun] and [light] are used as seemingly innocuous symbols referencing a counter-Divine Will basis and agenda, to the apostate system. I'm not sure what one can do with a system like that, which presupposes that everything references a counter-Divine Will basis. That doesn't appear to leave much room for free speech let alone freedom of Choice. And that certainly threw the connotation of the Egyptian [Sun] idol [Ra] into doubt as well.

So in evaluating this I researched more about the obvious thing, the [Isis]-[Horus]-[Osiris] mythology and its organizing symbolism. Not because they were particularly credible; nothing on a counter-Divine Will basis is. But rather as a pattern of manifest evidence of the activities and practices of the apostate system. [Osiris] appeared to represent the recognized authority figure within the apostate system, [Isis] his consort representing the organization's non-overt activities, and [Horus] as the potential next officeholder replacing, and becoming, the next [Osiris]. [Osiris] was associated with [the dead] and [the afterlife], agriculture, and variously [life] and [resurrection]. Also with [obelisks] in reference to his missing anatomy, and when

[Horus] became [Osiris] he'd "lose an eye", just like the Germanic [Odin] had. Same template, and there [Odin] both [did] and [lost an eye] to achieve new knowledge. Taken together and given the context, this would appear to non-overtly imply 'gaining access to the [third eye]', that is, to the capabilities of the telepaths and propheciers, upon taking office. The apostate system implies that counter-Divine Will symbols including 'suckage' are 'inversion' symbols, you see. They're not, of course. They're counter-Divine Will symbols. Therefore what we'd appear to have is a rejection of a Divine Will-aligned basis as part of 'taking office', which would certainly add up. So what is this? Is it, *'If the apostate system can't get you to sell out on Divine Will for any lesser thing, they'll offer you the whole operation and some metaphysical perks to accomplish it'?* Disturbing thought.

It certainly would be consistent with its symbolic depiction of franchise operations as being [in front of] something or someone else. [Shields] and so on. As in, *'whatever it takes to cover up True Nature and gain acceptance for same'*. I'm trying to clearly illustrate the evidentiary basis for My concerns here because it's not like I'd just pulled them out of My armpit or something.

I started to evaluate what the Bible had to say about the apostate system. It had already correctly identified Rome and Babylon as the culprits of what it calls 'the beast [system]'. Where did its counter-Divine Will basis originate? It additionally declares that 'the beast [system]' gets its power and its authority from "the dragon", a reference to Christianity's principal 'adversary' figure. I started to contemplate how the apostate system's 'higher level' operatives were telepaths, propheciers and occultists, and how Rome has frequently been seen to use supernatural physical manifestations both directly (supposed 'miracles') and indirectly (such as having priests conveniently appear to put a stop to supernatural disruptions, thus lending perceived credibility and authority to Rome). Waaaaaitaminute. This doesn't look right.

And then I happened to find this guy, the Egyptian idol [Amun]. He was right up there with [Osiris], hyped about as much, but yet he *wasn't* [Osiris]. Who'd be that important in their scheme of things, without being any of the usual suspects? Let's take a look at some of his characteristics: two very pronounced vertical 'plumes' on his head, associated specifically with the [ram]-headed sphinx, associated with [air] (meaning spirit, the unknowable and unseen, or plans and strategies beyond the ken of the average person), and his name meaning something like 'the hidden one' or 'invisible' or 'mysterious of form'. ***[And unlike most other Egyptian idols], he was considered Lord of All who encompassed every aspect of creation.'***

Categorized as a formative universal entity, he was eventually lumped in with [Ra], their [sun] idol comparable to [Baal] I'd mentioned, and ***'held the position of transcendental, self-created creator deity 'par excellence'.*** Kind of a self-made man, eh? So the apostate system's answer to the Ultimate Creator or at least one aspect of it, but with some definite causes for concern given the larger context. If these guys are, self-evidently, on a counter-Divine Will basis and regarding a counter-Divine Will-based non-physical entity as the Ultimate Authority, that would account for practically their entire organizational history. It would also put them on a mutually-exclusive basis with a Divine Will-aligned basis for as long as they continued to Choose a counter-Divine Will basis.

So let's analyze this according to the existing and prevalent 'rules' for a moment. For starters, in presenting a position which symbolically prevaricates between upholding a Divine Will-aligned position (for example, implying that they're securing things by ensuring that counter-Divine Will-insistent personnel are brought under control, versus only maintaining a pretense of same and doing 'business as usual') they're already perpetuating an invalid position referenced by their own [palindrome] symbol. You know, the symbol where something is supposed to read as either legitimate or on a counter-Divine Will basis.

Next, in implying such a basis they appear to be proffering me 'benefits' (in this case, the forfeit of the now thoroughly mortgaged and in hock apostate system to Me) if I will accept a counter-Divine Will basis which would de-legitimize My position. As the old phrase goes, *'that's just dickering about the price'*, because offering things in return for accepting a counter-Divine Will basis is 'business as usual' for the apostate system, at least in this revision of the timeline.

As for implying that they're *'working non-overtly to uphold and enforce Divine Will'*, never mind that they appear to be adopting a counter-Divine Will basis as the mainstay of their implied effort, that's invalid for a few reasons. Firstly because they'd manifestly already *'spent that nckel'* when they sought to convince the public that 'their' Freemasons were doing that for quite a while. In fact, they were manifestly using the lack of clear and distinct positions to incrementally subvert personnel onto a counter-Divine Will basis. Next, because it flubs the 'duress' test. Those personnel? Already under apostate system control. No 'duress' there, except perhaps that which the apostate system itself has caused, and sorting that out retroactively has been shown to be quite within 'their' capability. Then there's the fact that with a fundamental shift onto a Divine Will-aligned basis the idea of rank and file personnel in opposition to it, something which is better for everybody, is not only "absurd" but sounds like still more disrespect from here. And with so much to sort out directly via 'high level' contacts, there doesn't appear to be any necessity to wait for 'the rank and file' to get sorted out regardless. Not to mention that in the interim the apostate system is still causing, directly and indirectly, all manner of oppression and Divinely-conferred rights violations of which it still does not seem to count the cost nor liability. And some of that it continues to inflict upon Myself, directly and indirectly.

While they've been retaining this invalid position, they've also been using as I'd mentioned 'null symbolic mode' signifiers. Their [blue] indicating *'a purely temporary agenda or state of affairs, not meant seriously nor to last'* for example. We've however seen that before, such as in the flags for the United States and geographic so-called 'Israel', but that hasn't kept those *'temporary states of affairs'* from lasting however long was deemed necessary, nor kept them from violating Divinely-conferred rights. They've also been deploying symbols like [animals] which imply, in the lingo of My "house" and depending on context, a sort of personal, informal, unofficial, 'don't quote me' basis, which can also mean that symbolism proper should be discounted and the messaging is meant to be interpreted purely overtly (not that the apostate system's overt basis is any more legitimate). Now, there are various symbols My "house" uses to indicate unofficial or 'overt-only' modes and while most are more or less interchangeable,

the connotations of some often provide ‘nudges’ of context depending on which are selected for use. In this situation for example, we don’t have [animals] indicating a sincere, benevolent, affectionate close relationship going on here where mutual trust has been established and everyone knows they’re on a legitimate basis. Given the Choices and behavior of the apostate system for as long as I’ve known them, and indeed throughout its organizational lifespan if overt history’s any reliable indicator, indicator symbols like [one-handed], [foreign languages] and [international], [nonsense words], [peripheral], and [d█rk] or [bl█ck] would have been more appropriately used in this context. Those tend to imply more of a *‘cannot be taken seriously for reason of having an invalid counter-Divine Will, counter-True Nature basis’* explanation. Indeed, it’s that solid basis long established on the part of the apostate system which it now finds it needs to sort out, and is doing practically the opposite by remaining on a counter-Divine Will, counter-True Nature basis for quite a long while rather than correct that on its own, then by taking needlessly long with Me while *still* continuing it, and now with both a prevaricating and invalid position and literal and symbolic “tardiness” as well.

There is a valid, worthwhile and legitimate place for literal humor. That place is not however in attempted substitution for remedy, justice, restitution nor establishing a valid and legitimate position in alignment with Divine Will and ones’ Divinely-conferred True Nature. In fact the apparent effort to misuse it like that comes off more or less like the Knights of Malta personnel being rude, abusive, disrespectful, blasphemous and incrementally sociop█thic and trying to get it excused as *‘Just kidding!’*. What is more, apparent efforts to try to ‘haggle’ about whether or not to get onto a valid and legitimate Divine Will and True Nature-aligned basis is, itself, a rejection both of Divine Will *and* ones’ True Nature.

A refresher: The apostate system absolutely refused to sort itself out with regard to a valid and legitimate Divine Will- and True Nature-aligned basis, implying that a years-long “scan” of Myself had to be successfully completed first. To the best of My knowledge that supposed duration has now lapsed, and we continue not to find it back on a Divine Will- and True Nature-aligned basis and prevaricating about same. The literal time they’d (however non-credibly) implied they absolutely needed has now lapsed, they’re in hock with regard to Divine Will principles and routine, systematic violations of Divinely-conferred rights, and they still haven’t adopted a valid and legitimate basis. Indeed, they appear to be prevaricating on whether or not they intend to. Time’s up, and I’ve managed to supply grace and patience while still upholding Divine Will and refusing to actively or passively enable their behavior on an invalid basis in the interim.

Incidentally, ‘haggling’ on Divine Will principles and True Nature being itself a rejection of both, I must decline to have a professional relationship with them on an ongoing basis of such ‘haggling’. If ‘their’ personnel can’t manage a Divine Will- and True Nature-aligned basis they’re in the wrong business. I don’t mind occasional discussions with people about how rights, Divine Will principles and True Nature work; I actually find them quite stimulating. But while I and others remain under direct and indirect ‘duress’ from an oppressive apostate system which remains on an illegitimate counter-Divine Will, counter-True Nature basis is not the situation in which to have those, and neither is having them continue with ‘business as usual’

while I have to labor under the oppression caused by ‘their’ system *and* write up releases clarifying and evaluating behavior they shouldn’t have been doing in the first place. That’s hardly fair, and if it’s not fair it’s neither in accordance with Divine Will principles nor True Nature.

‘Start as you mean to go on’

Let’s suppose for the sake of argument that the apostate system *were* to Choose to realign with Divine Will principles and True Nature. What would that look like? They’ve been manifestly oppressing and persecuting Me via [fright] as I’ve mentioned in some of My other releases, along with plenty of disrespect and abuse, indirect physical injuries, and of course ‘their’ telepaths and propheciers pulling personal and private data right out of My mind through metaphysical force and then ‘uploading’ some of it through the non-overt network for use in even more psychological abuse. That last of course violates the ‘persons and papers’ Amendment established by the apostate system, and established at least in part to prevent violations of a Divinely-conferred privacy right. And since the apostate system manifestly remain on a counter-Divine Will, counter-True Nature basis, they necessarily lack a valid, legitimate and Divine Will-aligned jury to provide some equivalent of a warrant for same.

How does an organization recover from that? How does it successfully ‘make nice’ in the aftermath?

The routine and systematic violations of Divinely-conferred rights by the apostate system doesn’t end with those against just Mine though; distinctly not. Even ‘their’ overt ‘news’ media routinely presents reports of all manner of rights violations directly and indirectly caused by the apostate system, in ‘developed’ countries and ‘struggling’ countries as well. In fact that had been My first very solid indicator when I’d started that whatever was going on, it was on an illegitimate basis, one which I now recognize as a counter-Divine Will, counter-True Nature basis. In fact it was having established that which had greatly influenced the variety of options in counter-response which it made perfect sense to deem fair, legitimate and valid in striving to put things right; what I now know of as the apostate system had plainly and manifestly jettisoned a legitimate basis. An entity knowingly, Willfully and avoidably outside the law has no recourse to law, by its own Choosing.

But all this certainly didn’t start with modern history either. As mentioned, it’s manifestly been on a blatantly counter-Divine Will, counter-True Nature basis for umpty-thousand years now, and by all the available evidence has been quite content to do so in the course of its empire-building agendas. This of course means that its expansion, its resources, its clout and influence, and its personnel are effectively all ‘blood money’. They’ve been acquired in direct and gross, wholesale violation of Divinely-conferred rights which any Divine Will-aligned system would recognize as inherent to all. British colonialism *née* American militarized colonialism is just one convenient example in recent history; just about every major manmade atrocity would have to

be included, along with the Crusades, Inquisitions and the expansions of various apostate system franchise overt empires throughout history, all the way back. Heck, even the domestic deterioration of morality and law, and the injustices and quality of life detriments that has caused, have frequently been the results of the standard practices of the apostate system. Manifestly the organization has in effect been conducting a 'war on civilization' which has been an unqualified success, emphasis on 'unqualified'.

A system which does that has plainly already de-legitimized itself. It cannot validly flout 'the rules', that is, Divine Will principles, True Nature and Divinely-conferred rights the whole way through and then at the finish make a legitimate claim to success; everything it has gained, through force or guile, has been forfeit. Its remaining options are to push through an illegitimate 'victory' through force of numbers, which it appears to have been trying to do, or to somehow genuinely re-legitimize itself. *"To revitalize itself"*.

So how would that look, d'you suppose? If it were to transition from an invalid counter-Divine Will, counter-True Nature basis onto a valid Divine Will- and True Nature-aligned basis, it would presumably have to forfeit everything it's acquired on an illegitimate basis. It would also have to make complete restitution, commit permanently to a such a basis, and manage to convince everyone that it had done so. Given its manifest organizational history that last would be particularly interesting, given that it now 'has a rep', particularly for presenting nicely to the public when it deems it has to and yet establishing various unfamiliar symbolic lingo connoting a counter-Divine Will, counter-True Nature basis and regrouping yet again.

I suppose the capabilities of the telepaths and propheciers would come in quite handy in establishing that, except that in practically every circumstance that would violate the Divinely-conferred right to privacy. That 'persons and papers' thing I'd mentioned, remember? There'd have to be the equivalent of a valid warrant for that, and without a Divine Will-aligned jury to provide one it presumably couldn't be done by anyone on a Divine Will- and True Nature-aligned basis.

Then there's the fact that, as we've seen, the apostate system appears to have by now co-opted *practically every concept* for use as either a counter-Divine Will symbol, or as some other kind of derivative symbol which is either presupposed to be on a counter-Divine Will basis or interpreted as being on one in the presence of any counter-Divine Will symbol. We can hardly talk anymore while retaining a clear distinction, let alone use non-overt organizing symbolism without the presupposition of a counter-Divine Will basis in effect.

Another thing compounds the situation here. It's all great to suppose that, 'Sure, it's an organization which has committed quite a lot of regrettable incidents throughout history, but I'm sure it's very sowwy for them now and has totally changed for the better.' Except of course that in this case, with the retroactive editing capabilities of the telepaths and propheciers, the apostate system evidently has the means right now in the present to retroactively 'edit away' those incidents and the counter-Divine Will, counter-True Nature basis which caused them.

When you have the means to correct an injustice and you do not, you've Chosen the injustice. (*'Qui non obstat quod obstaré potest facere videtur.'* *'He who does not prevent what he can, seems to commit the thing.'*) That would appear to indicate that the apostate system *right now* still retains the Will to commit every unconscionable thing it has ever committed within its manifest organizational lifespan, pretty much the whole of human history. That alone chucks out concepts like *'benefit of the doubt'* pretty much completely. I'm a fair man, but *'a fair man'* is quite a distinct thing from *'a pushover'*. Indeed, fair men tend to have a much more solid basis than unfair men.

'The meek shall inherit the Earth, for they are too meek to refuse it.'
- Rodney Dangerfield, paraphrased

With those considerations in mind, we should now consider the apostate system's (non-credibly) implied transition to recognizing My Divine Will-derived authority. How could someone Divine Will-aligned even legitimately accept such an empire whose pretty much whole basis is that of *'blind money'*? Just about everything it's acquired, it appears to have manifestly acquired through force or guile, both implemented on a counter-Divine Will basis. I'd greatly prefer to get in there and sort the thing out, getting it back onto a Divine Will- and True Nature-aligned basis, yet it appears to be like being presented with a grandiose computer system whose peripherals all aren't [cold] enough to actually [touch], at least not [touch] and still [live]. Perhaps this would account for the apparent manifest succession of [Osiris] figures on a counter-Divine Will, counter-True Nature basis. Clearly the system would need to be made [cold] first to accept it. Nor is the *'presentment'* of this particular system just some arbitrary *'benefit'* or *'windfall'*, either. It's due and owing, and indeed past due.

Whenever we're *'stuck'*, it helps to return our attention to Divine Will principles for the solution. For example, we know that everyone's intrinsic, Divinely-conferred True Nature is, at core, designed to Will for Divine Will-alignment. In other words it's nobody's intrinsic True Nature to be a jerk, though we often find people doing some great impersonations of such. The True Nature of those in the apostate system is likewise so, "at core". All else is excess detritus. So in there somewhere in each of them is a worthwhile, benevolent person with a sincere desire and Will for Divine Will- and True Nature alignment and a valid, legitimate position and basis. How do we know when they've in fact Chosen that?

Presumably, when it's plain they have by their words and deeds. And through this evaluation I've presented, that's almost necessarily going to have to be retroactively. By now in this revision of the timeline the organizational legitimacy of the apostate system and all its holdings appears to have been invalidated, the organization has expanded almost completely in terms of tangible influence but is mortgaged and in default with regard to Divine Will and True Nature. And it's practically impossible to even talk anymore without having to contend with all manner of symbols and derivative symbols which the apostate system has by now co-opted and re-designated as having counter-Divine Will, counter-True Nature connotations.

A retroactive 'do-over' with the apostate system in alignment with Divine Will and True Nature throughout is something I'd planned to implement Myself. That's part of why I was essentially unconcerned about these releases; in a timeline in which the apostate system wasn't in fact apostate there would have been nothing to expose. And while it manifestly remains apostate it's forfeit anyway, and a serial offender. But it appears, unless I'm missing something here, that in order to accept 'inheritance' of the apostate system it's first going to have to be "cooled down" retroactively, and completely. It's all great receiving a transfer of recognized authority as required by law or as a form of restitution, but if that transfer of recognized authority comes with what appears to be a guarantee of symbolic [death] it obviously cannot be accepted on such terms. As familiar as the apostate system is likely to be with 'sellouts' who just can't wait to receive various 'perks' and 'benefits' for relinquishing their Divine Will- and True Nature-aligned basis, My desire has always been to sort all this stuff out and that means being legit. Otherwise we're just doing a slightly larger version of that same familiar '*political resistance proffered on a counter-Divine Will, counter-True Nature basis*' pattern and we know how well that actually works.

The apostate system appears to have noticed these assessments on My part, via telepathic capabilities presumably, and signalled them to 'their' rank and file via the recent media attention to the 'Princess Haya' item. Largest overt court divorce settlement, she's read a [poem] he'd written to her and between that and his behavior is convinced he's out to [kill] her. The [divorce] symbol purports to be symbolically 'inverted' to [marriage]. Part of the reason for the huge settlement is to enable her to [protect] the [lives] of her [children].

There are however a few snags with a retroactive solution. Those who haven't been privy to the non-overt information distribution from the telepaths and propheciers are probably best advised to hold on to something, because this is going to get even more interesting.

The first I suppose is the logistics of the thing. There's certainly no problem of which I'm aware to the feasibility and capability of accomplishing it; they've been retroactively adjusting things even just to have a word with Me, by placing non-overt symbolism in the media I happen to watch, even the older stuff made before I was born. As a 'sci-fi' reader the unanticipated effects of this are definitely cause for concern to Me, though being the one around whom they're organizing all this I'm presumably immune from being revised out of history as a result of it. Others, though? Perhaps not. No in terms of logistics I mean that there are some definite civilizational advancements which it would be ideal to 'send back' first before revising away this timeline. The centuries of fine-tuning of European Common Law for example; it would be less than ideal for humanity to have to rediscover the foundational principles of how justice works all over again. On the plus side, if Egypt and Babylon had known them and been applying them from the start what then? A Divine Will system rather than an apostate system, presumably. Then there's all kinds of scientific and technological discoveries, inventions and surveying information that it would have been a vast quality of life improvement to have had all along, even if they were only recorded theoretically and produced later once the prerequisite materials had been accumulated and techniques implemented. Now there's a comparatively

utopian society for ya: a free and fair system actually upholding Divine Will principles, rights and True Nature and practically instant quality of life improvements and technologies. What we in this time know of as the apostate system would instead be a genuinely Divine Will-promoting system and could instead have '*led by example*', producing all manner of improvements and civilizational 'upgrades'; who could reject it? (For 'Civilization' players, this is what's known as a '*cultural victory*'.) I suppose near the beginning there'd be a few foreign invasions and attempts to conquer, and those would presumably qualify as 'duress' and legitimize the use of non-overt methods to promote healthier ideologies '*from within*', similar to (but more benevolently than) this timeline's apostate system has made it its business to infiltrate, subvert, degrade and co-opt foreign nations. Given the drastic improvements all the above would provide for humanity, it seems a pity to just revise away what we've managed to glean in this timeline.

Then there are the personal and professional considerations. For example, the purpose here would be to retroactively get the apostate system onto a Divine Will- and True Nature-aligned basis. Yet until the system had "cooled off" enough for Me to "touch it", I couldn't have 'hands-on' with the project. Since I'm the legitimate authority through virtue of alignment with Divine Will, I'm not sure how it would get authorized let alone managed correctly. And any significant revisions of the timeline would presumably also revise away various events including, for example, encounters with people with whom I'd developed intensely meaningful relationships of significance. Taking those away from Me even inadvertently as a result of temporal revisions would be yet another violation of My rights, which would put the apostate system back onto an invalid basis again. Not sure how that would get sorted. I suppose they could just not mention it to Me, but that would hardly be particularly True Nature of them.

I'd be very interested in brainstorming all this stuff out with the apostate system, but of course that's untenable and unreliable at best and risky at worst while they remain on a counter-Divine Will, counter-True Nature basis. It does seem however like the only solution they've got is going to have to be some major temporal revision work, because to satisfy the position into which they've organizationally and collectively placed themselves the system has to "cool off" enough for Me to "touch it" before I can accept it, and the system as mentioned is thoroughly mortgaged, forfeit, due and past due in terms of Divine Will and True Nature. It harkens back to that '*man climbs outside of Great Pyramids*' item that I'd seen in the papers all those years ago; I'd presumably have to be symbolically "up there" yet "on the outside" of the thing in order to get the Work done. I mean, it's Work that we all need done and I suppose I can manage that; I obviously have to remain "outside" the thing or it can't get done. Guess they'd just have to keep revising the timeline until the system had "cooled off" sufficiently. I guess in a curious sort of way this would make a certain kind of sense. I mean, '*to accept control over the apostate system on its counter-Divine Will basis*' wouldn't be to actually gain said control over it; the counter-Divine Will basis would, as I read it, invalidate the thing and as the apostate system purports to read it, 'invert' the concept. The supposed 'inversion' would make quite a lot of sense given the context: it would've been to have accepted control of the apostate system, on its counter-Divine Will basis, over the individual. Suppose that would account for

the evident succession of [Osirises] ([Osiri]?) on a counter-Divine Will basis.

But acquisition of the apostate system was never the original intent. Sorting all this out was. I suppose if I'd been self-involved I could have easily conflated the one for the other.

Regardless the apostate system does rather appear to have '*painted itself into a corner*' by now, one from which it seems unlikely to extricate itself without a heck of a lot of major retroactive engineering Work ('*retrofitting*', perhaps). But when I'd encountered them knowingly, Willfully and avoidably violating My Divinely-conferred rights through having usurped My privacy and agency, I did protest to them there and then. I've summarized it on page [fifty-three] in the '[July Mega-Exposure](#)'. Their response implied to Me, though I was unfamiliar with their counter-Divine Will symbolic hypothecated basis, was a rather disrespectful commitment to sorting it out by chiding Me that they wouldn't have done all this if they weren't able to sort it. Perhaps they hadn't meant that, but I do intend to hold them to it. Those who usurp the agency, usurps also the liability. And in this timeline, what we've come to know of as the apostate system has usurped one heck of a lot of agency.

In the meantime they remain in default, forfeit and are now past due. While they do, or don't, whatever it is they're going to do, or not, can't determine whether or not I or the People more generally take action. It would be true to say that the apostate system to still have not come through yet eliminates from I and the People a number of peaceful, amicable options for resolving this. However, there remain options for resolution which are still peaceful if perhaps not quite as amicable. Truth, law, exposure, justice, civics, that sort of thing. Effectively the same thing I'd presented in My '[A Better Solution](#)' piece. I see that as a means by which I and the rest of the People can continue to uphold our duty to Divine Will, our True Natures and to our neighbors regardless of what the apostate system do or don't. If the apostate system indeed Works to sort things out, the results of a Divine Will, exposure and justice effort here in the present should be of no concern to them. If they do not, I'm not aware of a basis upon which they could have legitimate cause for concern.

Additional: For clarity, as the year was ending I was diligently evaluating the various situations we were reasonably likely to find ourselves in now and correlating them carefully against Divine Will principles. Specifically the apostate system's succession of recognized authority figures on a counter-Divine Will basis, and the inherent absence of the apostate system while it's on a counter-Divine Will basis. While doing that I was still keeping one ear on the 'news', and found that some of the non-overt signalling appeared to caution Me against credulity there. I remember this because the fact that the implied messaging aligned with positions I've long held caught My attention. I mention this now because now the apostate system appears to have started implying that I'd shifted My position on the basis of what 'their' own personnel had been putting out non-overtly, and that this indicates either trust on My part of personnel on a counter-Divine Will basis, or acceptance of things of value from same. Those implications are hardly true of course, and I add this for clarity precisely *because* I don't trust those who've knowingly, Willfully and avoidably adopted a counter-Divine Will, counter-True Nature basis. Nor should we. The apostate system has ostensibly been intensely cautious and thorough,

arguably needlessly so, to establish whether someone (in this instance Myself) is Choosing a Divine Will- and True Nature-aligned basis. We should also be intensely cautious and thorough with regard to it, particularly as after umpty-thousand years of cultivating a counter-Divine Will, counter-True Nature basis it has established quite a 'rep' for itself. *'The burden of proof'* that it's now Choosing a Divine Will-aligned basis is of course on it, and *'extraordinary claims require extraordinary evidence'*. So far, nothing. This is about whether the apostate system has been Choosing a fair, legitimate, Divine Will- and True Nature-aligned basis or not, and it always has been. Its efforts to shift the perceived topic to Myself are both as disappointing as they are telling about the counter-Divine Will, counter-True Nature basis the apostate system has manifestly been Choosing.

For whatever it's worth, I'd noticed something was off immediately. Took Me a day or so to get a read on the pattern coming off the apostate system, which was only 'due diligence', in an effort to find out what the heck they thought they were doing now. Or at least what they implied to think they were doing now. Then I started writing this release up. As per usual I waited until the numerology they'd infer from the release date would provide for as clear a statement of My Divine Will- and True Nature-aligned position as I can reasonably provide. On the basis of their long encroachment into My life and signals they'd put out at Me there's also an implication in the numerology of *'You just did something wrong'*, which also would be appropriate here. But I'd like to assure folks that it hadn't taken Me this long to evaluate the morality of what they've been proffering this time. The apostate system must have known I'd have to object to it; they've been proffering a situation which after all went in direct contravention with a number of things I'd been making clear throughout. Something of a waste of all our time, quite honestly. So no change there. I find their disregard for the Divinely-conferred rights of the People they're oppressing in the meantime, which to varying extents is each of us, just appalling. That surely isn't the Divinely-conferred True Nature of those who've been managing it, yet here we manifestly still are. There are people being oppressed right now who urgently need and deserve much better situations, and here is the apostate system continuing to implement the same counter-Divine Will-, counter-True Nature-based hokum on any number of trivial and irrelevant pretexts.
